

### California Longitudinal Pupil Achievement Data System

The statewide system used to maintain individual-level data including student demographics, course data, discipline, assessments, staff assignments, and other data for state and federal reporting.

Operational since 2009.

CALPADS data enables the California Department of Education (CDE) to calculate progress made by schools on the California State Priorities reported on the California School Dashboard (Student Achievement, Chronic Absenteeism, Suspension Rate, English Learner Progress, Graduation Rate, College/Career, Basic Services & Conditions at Schools, Implementation of State Academic Standards, Parent Engagement, School Climate, Access to a Broad Course or Student)




### California Longitudinal Pupil Achievement Data System

CALPADS contains demographic and discipline data (starting in 2015 for special education students) for ALL students but has never contained IEP-related data.



### California Special Education Management Information System

Database that stored and utilized special education student information at the state level. ALL SELPAs in the state were required to use the CASEMIS software and report special education date (IEP information) two times a year (December and June). CDE used the data to monitor special education programs for compliance and to address federal requirements for statutory and programmatic data for federal funds (school districts' Indicators on Annual Performance Reports).



# Application Program Interface (API) User Acceptance Testing - UAT

- Statewide pilot testing began in July 2019 and continued into August 2019
  - EV SELPA participated with Rim of the World USD
  - EV SELPA IEP Data system vendor, Faucette Micro Systems, created an Application Program Interface (API) to transfer student data from Web IEP to CALPADS
- Training for all districts in the use of API occurred:
  - September 16 EV SELPA




## Timeline for CALPADS Data Submission 2019

# EV SELPA LOW INCIDENCE PROCEDURES & GUIDELINES

California Education Code 56836.22 - As part of the Local Plan submitted to the State, each SELPA must:

 ✓ describe how funding for specialized books, materials, equipment and services will be distributed within the SELPA

 develop guidelines that include a summary of legal requirements and local procedures for students with low incidence disabilities.



# EV SELPA LOW INCIDENCE PROCEDURES & GUIDELINES

California Education Code 56026.5:

a low incidence disability eligible for use of low incidence funding means a severe disabling condition with an expected incidence rate of less than one percent of the total statewide enrollment in kindergarten through grade 12.

California Education Code 56026.5:

Students with a primary or secondary disability of –

Hearing impairment Deafness Visual impairment Orthopedic impairment Deaf-blindness

### 1.0 CALL TO ORDER

Chairperson Alejandre called the meeting to order at 2:01 p.m. in the East Valley SELPA Conference Room at 670 E. Carnegie Drive, San Bernardino, California.

### 2.0 ROLL CALL AND ESTABLISHMENT OF QUORUM

Quorum was established.

#### 3.0 APPROVAL OF AGENDA

A motion to approve the agenda was made by Member Binks and seconded by Member Elphic. The motion carried unanimously.

#### 4.0 PUBLIC COMMENTS

There were no public comments.

### 5.0 **RECOGNITION ITEMS**

### a. Retiring members of the East Valley Steering Committee were recognized for their contributions.

Chairperson Alejandre and Administrator Metheny recognized Janet Nickell, Director of Pupil Services for the Colton Joint Unified School District. Ms. Nickell was a member of the East Valley Steering Committee for approximately ten years. Administrator Metheny expressed her gratitude to Ms. Nickell for her service on the Steering Committee and for her more than 28 years of service in public education. Member Almendarez thanked Ms. Nickell for her many years of dedication to the students with disabilities in the Colton Joint Unified School District.

### b. Participants in the 2018-2010 EV SELPA Leadership Series were recognized.

Chairperson Alejandre and Administrator Metheny recognized participants of the East Valley SELPA Leadership Series. Those recognized participated in a four-part series in special education leadership focusing on organizational leadership, finance, personnel, compliance, special education law, and successful instructional leadership for students with disabilities. Participants included Kelli Cooper, Kristine Hubbard, Patricia Mbugua, Greg Minton, Todd Rossi, Tracy Schroeder, Andrea Tennyson, Tyrese Crawford, Sherril D'Espyne and Janice Morrison.

### 6.0 APPROVAL OF MINUTES

A motion to approve the March 20, 2019 Meeting Minutes was made by Member Almendarez and seconded by Member Binks. The motion carried unanimously.

### 7.0 DISCUSSION ITEMS

### a. SELPA Local Plan Requirements 2019-2020

Administrator Metheny shared a PowerPoint presentation regarding the requirements of SELPA Local Plan revisions in 2019-2020. She explained revisions required of all SELPA local plans due recent changes in California Education Code.

### b. Revised Annual Budget Plan Document with California Department of Education (CDE) Approval for Future Use

Administrator Metheny presented a recently CDE approved Annual Budget Plan document that may be required for future use. EV SELPA data for 2019-2020 was included in the Annual Budget Plan document for comparison to the current Annual Budget Plan document required by CDE. The revised document is formatted to include SELPA-wide and individual district specific budget information by revenue and expenditures. The new format may allow for better understanding by the general public. The Board discussed the value of the new format.

#### 8.0 ACTION ITEMS

#### a. Approval of the EV SELPA 2019-2020 Annual Service Plan

Chairperson Alejandre opened the hearing to Adopt the EV SELPA 2019-2020 Annual Service Plan at 2:35 pm. The hearing was closed at 2:36 pm. Administrator Metheny recommended the Board approve the EV SELPA 2019-2020 Annual Service Plan. The Plan describes the special education services provided by EV SELPA member school districts and identifies the locations where the services are provided. A description of each service code was also included with the Plan. Public notification of the hearing was sent to each member district for posting prior to the hearing. Each member district posted the notice as requested.

Motion to approve the EV SELPA 2019-2020 Annual Service Plan was made by Member Binks and seconded by Member Murphy. The motion carried unanimously.

#### b. Approval of the EV SELPA 2019-2020 Annual Budget Plan

Chairperson Alejandre opened the hearing to Adopt the EV SELPA 2019-2020 Annual Budget Plan at 2:38 pm. The hearing was closed at 2:39 pm. Administrator Metheny recommended that the Board approve the EV SELPA 2019-2020 Annual Budget Plan. Public notification of the hearing was sent to each member district for posting prior to the hearing. Each member district posted the notice as requested.

Motion to approve the EV SELPA 2019-2020 Annual Budget Plan was made by Member Almendarez and seconded by Member Binks. The motion carried unanimously.

#### c. Approval of the 2019-2020 EV SELPA Operations Budget

Member Elphic, a member of the 2019-2020 Budget Ad Hoc Committee, recommended the Board approve the 2019-2020 EV SELPA Operations Budget. Historically, the budgets of the EV SELPA have collectively been called the EV SELPA Operations Budget and approved annually by the Board of Directors. Motion to approve the 2019-2020 EV SELPA Operations Budget was made by Member Murphy and seconded by Member Elphic. The motion carried unanimously.

#### d. Approval of the 2019-2020 SBCSS Fee-for-Service Rates

Administrator Metheny presented the proposed 2019-2020 SBCSS Fee-For-Service rates. She reports that at the April and May 2019 EV SELPA Steering Committee meetings, the proposed 2019-2020 SBCSS Fee-for-Service Rates were reviewed. Member Elphic noted that the SBCSS East Valley Operations staff worked proactively in reducing costs; however, due to the current trend of declining enrollment and rising employee costs, overall costs continue to increase. Administrator recommended the Board approve the 2019-2020 SBCSS Fee-for-Service rates. Motion to approve the 2019-2020 SBCSS Fee-for-Service Rates was made by Member Binks and seconded by Member Almendarez. The motion carried unanimously.

### e. Approval of the Revised 2019-2020 EV SELPA Board of Directors Meeting Schedule

Administrator Metheny noted that the calendar of FY 2019-2020 EV SELPA Board of Directors meetings was approved during the March 2019 Board of Directors Meeting. However, the September date must be moved to accommodate the State of Education address by Chairperson Alejandre and the March date must be moved to allow Administrator Metheny to attend a meeting of the State SELPA Administrator Executive Team. Administrator Metheny has been nominated to a position on this team. Motion to approve the revised 2019-2020 EV SELPA Board of Directors Meeting schedule was made by Member Murphy and seconded by Member Elphic. The motion carried unanimously.

9.0 **OTHER:** Next Meeting as per the approved revised 2019-2020 EV SELPA Board of Directors Meeting calendar will be September 18, 2019.

Member Binks shared that the Yucaipa-Calimesa JUSD Board of Education is grateful and enthusiastic for the work Administrator Metheny is doing for the East Valley SELPA.

10.0 **ADJOURNMENT:** Motion to adjourn the regular meeting was made by Member Almendarez and seconded by Member Binks. The meeting was adjourned at 2:49 p.m.

### Jessica M. Lascano, M.A., LEP, NCSP, School Psychologist





**Content:** We all have a basic understanding of the principles of assessment. But, what happens when students are unable to sit at a table, point to a picture or symbol in a stimulus book or provide a verbal response, or engage in behaviors that impact their participation in testing? Typically we describe these students as untestable and resort to using assessment and evaluation methods that are less accurate and do not provide complete information. Would you like to learn strategies to enable students' communication and participation within the classroom through Augmentative and Alternative Communication (AAC)? If yes, this workshop is for you. Participants will participate in a fast-paced 2-day training with hands-on activities and walk away with materials and strategies to use immediately with students.

You will get a brief introduction to the basics of language development, communication purposes, the guiding principles of AAC and its different forms. We will cover the link between behavior and communication, the connection between AAC and literacy, and how 2 types of vocabularies can support communication. Participants will gain a basic understanding of how to identify the most effective communication mode for a student. Effective communication partner strategies and how to teach and model AAC will be demonstrated and practiced. A significant component of this training will focus on physically engineering the classroom to make communication available to everyone everywhere. Moreover, participants will learn about the selection of vocabulary for communication activities as well as how to integrate and plan communication opportunities throughout the day to support students' participation in the curriculum. Strategies for team collaboration around AAC, including working with parents, will be included. In addition, participants will learn about measurable AAC goals and data collection.

This class is a beginning level workshop. It does not cover programming of various AAC devices and systems. Rather, the aim of this training is to empower staff to use various AAC interventions and supports to provide communication opportunities for students throughout the day.



**Content:** According to the International Dyslexia Association, one half of all students who qualify for special education services are classified as having a learning disability. Approximately 85% of those students have a primary disability in reading and language processing. The National Institute of Health identified Dyslexia as the most common and prevalent of all known learning disabilities, affecting one in five children in the United States. #### **Advocates for Better Schools**

San Bernardino County District Advocates for Better Schools (SANDABS) is an organization of school district board members and superintendents representing the member districts of San Bernardino County on state and federal issues. Its purpose is to strengthen public education through legislation, and work collectively with associations and partners who share the common goal of providing quality education to the children of San Bernardino County.

SANDABS members include San Bernardino County school districts, special education local plan areas, regional occupational programs, and the County Superintendent of Schools. Member districts are eligible to have representation on the SANDABS Executive Committee, which is composed of nine school district board members, nine district superintendents, and the county superintendent. Superintendents are selected by region to serve on the SANDABS Executive Committee. School board members are elected to SANDABS by the San Bernardino County School Boards Association.

State and federal legislators and their staff are invited and encouraged to attend monthly SANDABS meetings.

#### **Benefits of SANDABS**

The Executive Committee directs the activities of SANDABS, which include:

- Monthly meetings with legislative updates from Sacramento and Washington D.C.
- Monthly legislative reports to actively track and monitor proposed bills as they progress through the legislature.
- Delegation trips to Sacramento to advocate for budget and legislative support for public education.
- The SANDABS Candidate Report, a resource for members, that provides candidates for State Senate and Assembly an opportunity to share their views and opinions on issues affecting public education.
