1.0 Welcome & Introductions

Chief Administrative Officer, Dr. Patty Metheny, of the East Valley SELPA Office, 670 E. Carnegie Drive, San Bernardino, California, called the meeting to order at 9:32 a.m. and shared the agenda on the screen. She welcomed everyone and asked attendees to introduce themselves.

2.0 Getting to Know One Another

Participants introduced themselves and shared a little about themselves.

3.0 Norms for Meeting

Dr. Metheny reviewed the current norms for the group. There were no objections or comments to continuing with the same norm.

4.0 What is a SELPA?

Dr. Metheny outlined the history of SELPAs in the state of California. She shared the governance structure as it relates to the East Valley SELPA as well as the October 2022 count of students with disabilities within the SELPA. The group learned about the mission of the East Valley SELPA and how it works together with its member districts to achieve its mission.

5.0 What is a CAC?

Dr. Metheny shared the purpose of a Community Advisory Committee, its governance structure, the role it plays in SELPA operations, and the insight parents provide in helping the SELPA learn about the parent voice. She shared examples of how the EV SELPA CAC has provided guidance and advice to her in the designing of the EV SELPA website as well as in collaborative efforts around potential legislation.

6.0 Review CAC Minutes – April 24, 2023

Dr. Metheny shared the minutes from the April 24, 2023 East Valley SELPA CAC meeting. Karla Kellems spoke about the title included in the minutes, "representatives present." She was concerned this gave the impression those listed are appointed by their local school boards and that she has not been appointed by her local school board. The Committee agreed to changes in the title for future CAC minutes. Katie Castruita made a motion to approve the minutes. Paula Bailey seconded the motion. There was no discussion. The motion passed unanimously by consensus.

7.0 Ed Code 51225.31 – Alternate Pathway to a High School Diploma

Dr. Metheny reviewed the required elements of the new Alternate Pathway to a High School Diploma and answered questions from Committee members.

8.0 California Pending Special Education Legislation

The Committee discussed current pending legislation related to Special Education that is on the Governor's desk pending his signature. The bills address inclusion and codify the technical assistance SELPAs provide in supporting districts in Differentiated Assistance as well as the requirement of an Annual Assurance Plan to address the needs of students with disabilities to be included in each local educational agency's Local Control Accountability Plan (LCAP). The Committee discussed the impact these bills might have on students and classrooms. Dr. Metheny provided context to the proposed bills and answered questions from parents.

9.0 EV SELPA Professional Development 2023-2024

Dr. Metheny introduced the EV SELPA Professional Development Catalog for the 23-24 School Year and highlighted the trainings that are available for parents. Colleen Meland reviewed parent trainings related to post-secondary outcomes.

10.0 EV SELPA Parent Resource Fair – November 3, 2023

Dr. Metheny showcased the upcoming EV SELPA Parent Resource Fair that will be held at the SELPA on November 3, 2023. The event focuses on free community resources that are available to parents of children with disabilities. Lunch will be available for all in attendance.

11.0 East Valley SELPA CAC Meetings for 2023-2024
