1.0 Welcome & Introductions

Chief Administrative Officer, Dr. Patty Metheny, of the East Valley SELPA Office, 670 E. Carnegie Drive, San Bernardino, California, called the meeting to order at 9:33 a.m. and shared a PowerPoint on the screen. She welcomed everyone and asked attendees to introduce themselves. Attendees shared about their children with disabilities and their interest in the CAC.
