1.0 CALL TO ORDER: SELPA Administrator Dr. Patty Metheny called the meeting to order at 8:00 a.m. via Zoom.

2.0 PUBLIC COMMENTS: There were no public comments.

3.0 REVIEW/APPROVAL OF MINUTES: The minutes of the September 16, 2021 meeting were reviewed. Motion to approve the minutes was made by Rob Pearson and seconded by Patti Buchmiller. The minutes were approved by consensus of the members present.

4.0 DISCUSSION/PRESENTATION

Finance Items

4.1 EV SELPA MOE SEMA & SEMB

Andrea Tennyson presented each district's finalized Maintenance of Effort (MOE) data for SEMA (Actuals) and SEMB (Budget) for review. Although there were minor changes from the preliminary data presented last month, all EV SELPA districts continued to pass for fiscal year 2020-2021. Ms. Tennyson explained the four possible exemptions available for districts to utilize and which exemptions were used (if any) by participating districts. Each district's Subsequent Year Tracking (SYT) form and Excess Cost report was also presented. Ms. Tennyson will secure all signatures ahead of the CDE submission date of November 15, 2021.

4.2 EV SELPA Fiscal Reporting Calendar 2021-2022

Ms. Tennyson reviewed activities for the month of October and November. In addition, she reviewed that activities, including SEMAI, to assist with MOE reporting and tracking were added in December, February, March, and April.

Program Items

4.3 EV SELPA DPDR (ADR) & Learning Plans

The Alternative Dispute Prevention and Dispute Resolution for East Valley SELPA was shared. This plan was submitted to CDE on September 28, 2021 (ahead of the October 1st deadline). The EV SELPA submitted each member district's Learning Recovery Plan on the same date. Dr. Metheny was notified of receipt of submission by CDE on September 30, 2021. Starting in November 2021, the EV SELPA will establish oversight reporting processes to ensure the implementation of the plans. Although CDE has not yet established a process to amend or change the plans, Dr. Metheny advised districts keep all documentation of any changes in case CDE requests them.

4.4 EV SELPA Additional Support Assessment

Program Specialists, Susanne Ferguson, and Mary Anne Klenske, presented the newly minted EV SELPA Additional Support Assessment guidebook and forms. Ms. Ferguson explained the new guide follows closely the principles of the previous assessment to determine the need for a 1:1 aide. She reviewed and explained the areas of focus, steps, and forms to use to perform this assessment. Training for use of the guidebook and forms is scheduled for December 2, 2021. A flyer with information with information about the training was provided. The guidebook and forms will be located in the "staff" potion of the East Valley SELPA website secured side. Rob Pearson spoke about a process he has required staff use prior to completing an assessment for the need for additional support. He

requires a Functional Behavior Assessment (FBA) and Behavior Intervention Plan (BIP) be completed as many of the requests are due to concerns with student behaviors. Dr. Metheny described how this may be appropriate but cautioned that an FBA and BIP are not a substitute for an Additional Support Assessment when an assessment to determine the need for a 1:1 aide is requested.

4.5 Compliance Monitoring Updates

Dr. Metheny provided information for CDE specific to the proposed IEP Implementation process as CDE has been ordered by a federal judge to provide oversight for the delivery and tracking of special education service minutes as outlined in each student's IEP. Data collection will be done independent of CALPADS, and it is slated to begin with the 2022-2023 school year. CDE will engage in a pilot program for this purpose in Spring 2023. Dr. Metheny has not volunteered any EV SELPA districts for the pilot.

A conversation regarding the tracking of service minutes ensued. As a result, the EV SELPA will work with Faucette Microsystems designers of the WebIEP to determine if a service tracking tool can be incorporated into the current program as well as reach out to other vendors with service tracking tools. Dr. Metheny will gather that information and bring it to a subsequent Steering Committee meeting. She also suggested each district special education administrator work with Cabinet level staff to share this new requirement and how it may affect workload issues.

Anne-Marie Foley presented an update on CDE's plans to monitor overdue initial, annual, and triennial IEPs in 2021-2022. In preparation, Ms. Foley presented district specific data for each type of overdue IEP based on a run of the data within WebDA on October 6, 2021. She contrasted this data with data previously presented. Although progress was noted for initials and triennials, there was an increase in overdue annuals.

4.6 CALPADS

Ms. Foley presented information regarding CALPADS Flash #213 pertaining to Fall 1 Submission. Fall 1 submission opened October 6, 2021, with Certification deadline of December 17, 2021. Terminology in CALPADS has changed: Code 20 – Annual Meetings are now called *Plan Review Meeting* and Code 40 – Triennial Meetings are now called *Eligibility Evaluation Meeting*. Ms. Foley also reviewed Input Validation Rule 0360. To avoid this input validation disability code 310 – Multiple Disabilities (MD) - must be listed as the primary disability.

CALPADS Flash 193 (program setting for 5-year-olds) was previously discussed. Ms. Foley reminded the directors that these students must be reported as preschool. If needed, an amendment must be held and back dated to change the student's setting to avoid certification error 167 or 168. Ms. Foley will run a report for each district to assist with clearing these fault codes.

4.7 EV SELPA & State SELPA Websites

Dr. Metheny showcased the EV SELPA and the State SELPA Administrators Websites. She shared that information and resources in both websites are available to the public. In

addition, the EV SELPA website has a secure, password access side for member district employees to access EV forms and other documents.

4.8 EV SELPA IEE Policy Update

Dr. Homutoff shared the updates to the EV SELPA IEE policy made to reflect current pricing for evaluations. The list of assessors was also updated. He remarked this list is not comprehensive and should not limit parent's availability to request a particular assessor. However, an assessor must possess the credentials necessary to perform the assessment. The policy is available in both, English and Spanish, in the East Valley SELPA website.

4.9 SBCSS East Valley Operations

Dr. Wyatt provided updates on professional development being provided to East Valley Operations staff with an emphasis on intensive training in curriculum use and implementation.

He also shared about ongoing student absences. District directors shared common experiences as students return to full time in-person instruction while the pandemic has not passed. There has been an increase in absenteeism in particular for the Visually Impaired class at Highland Grove. Dr. Wyatt will investigate to find out why this class has been particularly affected.

Dr. Wyatt also reported that he is anticipating a school nurse shortage in the region. Both school nurses currently staffed at the East Valley Operations will be on leave shortly. Conversation regarding degree requirement for insulin administration ensued. Derek Swem will share Court Ruling on staff allowed to administer insulin to a child in school.

4.10 Hot Topics

A discussion pertaining nurse's assessment of every student for every initial and triennial IEP ensued. It was clarified that health assessments by school nurses are only required if there is a health concern or if the student requires a health plan.

Dr. Homutoff reminded the committee that the Surrogate Parent training is scheduled for October 28, 2021. To date, only one participant has registered. Directors were encouraged to recruit appropriate personnel to become surrogate parents in their district.

Starting Monday, October 18, 2021, East Valley SELPA staff and contractors will carry with them an attestation letter complying with the Public Health Order of August 11, 2021, regarding COVID-19 vaccination or weekly testing.




Funding Adequacy Concerns Persist

Special Education received historic increases to base rate, a compounded COLA, and increases in targeted funding. During a time of declining enrollment for East Valley SELPA, these investments ensured we received increased funding. Despite these increases, our local general fund contribution averages over 54%.

Funding Inadequacy Continues







General Fund Contribution Continues to Grow

In East Valley SELPA, 54% is the average local fund contribution. Some LEAs contribute more, some less. Statewide the average is 67%.

Federal Increases Modest

Despite a federal obligation to provide for 40% of the excess cost of educating students with disabilities, the federal share of special education resources in California is a little more than 8%.

Mental Health Funding

SELPAs in CA receive \$69 million in Federal IDEA funds allocated based on SELPA ADA. The funds are allocated at the SELPA level. In the East Valley SELPA, these funds are provided directly to its member LEAs.

The State made the use of mental health funds more flexible in 2019. The flexibility influenced our allocation of funds directly to LEAs based on Prior Year P-2 ADA.

East Valley SELPA received \$890,579



Low Incidence Funding

Funding for Low Incidence pupils was historically around \$446 per eligible pupil.

In 2020 that amount increased to over \$3050 per eligible pupil.

2021-22 Budget Act increased this funding further by adding an additional \$23 million statewide. The amount in East Valley SELPA is \$3,050.43 per eligible pupil for a total apportionment of \$1,842,460.58.

15% of that amount stays with the SELPA for the purchase of materials & equipment. The remainder is provided directly to member LEAs based on their number of pupils with low incidence disabilities in the previous October count.

Special Education Early Intervention Preschool Grant


Originally included in the 2019-20 Budget year as one-time funds to District of Residence in the amount of approximately \$9050 per preschool student

No Grant in 2020

The funding used the prior year was used to increase the special education base grant to the \$625 level.

2021-22 Budget - \$260 Million

Budget allocates funds on an on-going basis, with additional restrictions to ensure expenditure that directly impacts inclusive preschool services/settings. Estimated to be \$5900 to District of Residence.



COVID-19 Special Education Impact

One Time funds included in 2021-22 Budget of \$550 Million Dollars

Funds allocated to the SELPA. East Valley SELPA retained 20% of Dispute Prevention and Resolution Funds. The remaining funds and all of Learning Recovery Funds allocated directly to members LEAs based on 2019 pupil counts.

SELPA submitted a plan for regional and local activities to support Students with Disabilities.







FEDERAL MENTAL HEALTH



FY 2021/22 BUDGET INFORMATION REGIONALIZED SERVICES/PROGRAM SPECIALISTS (RS/PS) BUDGET

The East Valley SELPA Program Specialist/Regional Services (PS/RS) budget is the operations budget for the SELPA administration.

Revenue Sources:

Funding is provided through AB 602 from two sources, the RS/PS funds and 1.50% of total AB 602 SELPA revenue. Revenue COLA increased from 1.50% to 4.05% and applied to PS/RS amount. AB602 per pupil base amount increased to \$715. The SELPA Board has authorized this distribution as "off the top" (Resource 6500).

~ Resource 3315 Preschool Local Entitlement estimated at \$19,394 (5% of total grant)

Budget Developed:

- ~ No ADA growth is projected for FY 21/22. Funding is projected on 20/21 P-2 ADA of 76,486.91.
- ~ 2.50% potential salary increase is estimated. Actual salary increase will be based on the average of 12 benchmark districts in the county who settle CTA salary schedule negotiations plus .25%. Step and column fully funded.
- ~ Health & Welfare Rates developed with a 5% inflationary increase for Medical, Dental, Vision, & Life.
- ~ Employer paid statutory rates are as follows: (from budget assumptions to current)

 - >Medicare 1.45% (no change) >UI from .05% to .50% >W/C from 3.06% to 2.92%
- ~ Information Technology user fee at \$2,428 per FTE, an increase of \$221 per FTE from prior year's rate of \$2,207.
- ~The 21/22 approved Indirect Cost Rate for County Schools is 7.85% a .15% decrease from prior year's rate of 8.00%.

New Opportunities for System Improvements

- Universal Transitional Kindergarten (TK) and Pre-K Planning and Implementation Grant Program.
- CSPP Expansion.
- Increase reimbursement rates, fee waivers, and transfers in contracts.
- Expansion of Supporting Inclusive Practices Preschool Grant.
- Multilingualism and Dual Language Learner (DLL) Funding.
- Updating English Learner roadmap and expanding DLL grants.
- Credentialing and refresh of Early Childhood Educator Specialist.

2021-22 Budget for Early Learning

- \$300 million in Universal Prekindergarten (UPK) Planning and Implementation Grants:
 - \$200 million for local educational agency (LEA) grants.
 - \$100 million for workforce development.
- \$130 million for LEAs CSPP expansion:
 - Part-day and full-day CSPP slots.
- \$10 million for the California Department of Education (CDE) to update the Preschool Learning Foundations and adapt the Desired Results Developmental Profile assessment and include direct assessments of literacy and math.

Update on Transitional Kindergarten (1)

- Universal TK will be phased in over five years until all four-yearold children are eligible by September 1, 2024.
- 2021–22 is a planning year where LEAs will be required to address issues regarding the TK implementation including: Workforce, Facilities, Children, and Programs.
- Requires new quality improvement conditions including reduced group size and adult-to-student ratios.
- Extends deadline to meet TK teacher requirements to August 1, 2023.

Update on Transitional Kindergarten (2)

- California could serve as many as 345,000 more children in TK.
- LEAs who provide TK will be able to use average daily attendance as the funding source.
- TK is optional. Parents can continue to enroll children in CSPP, federal Head Start, or private programs.
- Requires new quality improvement conditions including reduced group size and adult-to-student ratios.

Update on California State Preschool Program (1)

- Budget provided \$130 million to expand CSPP, a means tested part or full-day program, which serves eligible three and fouryear-old children.
- Both LEAs and community-based organizations operate CSPPs.
- Expansion funding specifically targeted to LEAs based on the funding source.
- Clarifies that TK eligibility does not impact family eligibility for other early learning and care programs.

Update on California State Preschool Program (2)

- LEAs will partner with Title I, Special Education, Expanded Learning and Nutrition services to build innovative models that:
 - Create seamless full-day experiences,
 - Are fully inclusive, and
 - Support and sustain home language for multilingual learners for all four and five-year-old children.
- LEA and community based organizations operating CSPPs will move toward serving younger children, especially three-yearold children.
 - In 2019, 60.4 percent of three-year-old children eligible for a state subsidized program were not enrolled.

Overview of Preschool to Grade Three (1)

- The vision for P-3 is to improve the quality and coherence of children's learning opportunities by focusing on:
 - Experiences children have in early learning settings:
 - Preschool, Head Start, CSPP, and TK.
 - Experiences children have in elementary school:
 - Kindergarten through third grade, and beyond.
- High-quality, inclusive early education can dramatically improve child outcomes.
- Aligned and supportive early elementary experiences are necessary to sustain gains.

Overview of Preschool to Grade Three (2)

- Support expansion of high-quality preschool programs.
- Create equitable access to preschool, and to early intervention and parental support services.
- Implement best practices for multilingual learners.
- Actively dismantle inequities.
- Sustain early gains.
- Support P-3 workforce.
- Collect, integrate, and use data.

Opportunities and Reflections

- As the CDE is working to increase the number of children fully served in inclusive early education settings and with UPK planning taking place, how can you engage in the planning process at the local or county level?
- Who are the Early Education Directors, Assistant Superintendents, and so on who you need to contact to ensure that special education is represented in the plan?


